



# SAN BERNARDINO COUNTY NOTICE OF HEARING

**NOTICE IS HEREBY GIVEN** that the San Bernardino County - Department of Public Works on **MONDAY, DECEMBER 30, 2024, AT 9:00 AM** will conduct a public hearing regarding the renaming "SQUAW COURT" to "THINYA'AAK COURT."

California Advisory Committee on Geographic Names (CACGN) has petitioned to San Bernardino County to change the name of "SQUAW COURT" to "THINYA'AAK COURT" in the Big River area. The request has been made to be compliant with Assembly Bill (AB) 2022 (Ramos), Chapter 479 of 2022 Statutes to remove the term squaw (sq\_) from all geographical features.

Under the new law, the word "sq\_" has been declared an offensive ethnic, racial, and sexist slur and public agencies and the California Advisory Committee of Geographic Names (CACGN) are tasked with working collaboratively with California Native American tribes to determine respectful replacement names. The San Bernardino County Public Works Department has consulted with the Colorado River Indian Tribal Leaders, who have proposed the new street name "THINYA'AAK COURT."

SAID MEETING will be conducted in the Department of Public Work's Hearing Room, 825 East 3rd Street, First Floor, San Bernardino, California, where all interested persons may be present and be heard.
